The Lord Mayor's Dragon Awards 2022

DRAGON AWARDS DINNER

Since they were founded in 1987, the Awards have attracted high quality applications from a variety of companies and community organisations throughout Greater London and the UK.

Dragon Award winners are recognised for their achievements in social impact. All finalists are invited to an annual awards ceremony hosted by the Lord Mayor at Mansion House.

This prestigious event presents a chance for applicants to share experiences and innovative practices in Responsible Business. It is an opportunity to find out more about ways in which London-based businesses are actively helping to fight social exclusion and build stronger communities.

MANSION HOUSE

The Lord Mayor had no official residence before the present Mansion House was built. They lived at their own house in the City and entertained there if the premises were large enough. Otherwise, the Lord Mayor offered hospitality in the hall of one of the City's Livery Companies, while great civic banquets and ceremonial occasions took place in Guildhall.

After the Great Fire of 1666, the diarist John Evelyn presented Charles II with a scheme for rebuilding the City which included a 'magnificent house for the Lord Mayor'. In 1728, a committee decided to build the house at the site of the ancient Stocks Market. This lay at the intersection of Cornhill, Threadneedle Street and Poultry, with the Royal Exchange and the Bank of England nearby - placing the Mansion House firmly in the commercial heart of the City.

An architectural competition was held, which included James Gibbs, John James and the City's own architect or 'Clerk of Works', George Dance (the elder). Although some other proposals were considered architecturally superior, Dance's plans made the best use of the intended site.

Construction began in 1739 and the house was first occupied in 1752 by Lord Mayor Sir Crispin Gascoigne, with the building being completed in 1758. The Italianate design has a façade with six Corinthian columns supporting a sculptured pediment, in imitation of a classical temple in the Palladian style. The internal layout included an open courtyard, covered over in the 1790s by George Dance the younger, son of the original architect, creating the current Salon. The Egyptian Hall is based on a drawing by Palladio showing an Egyptian dining hall as imagined by the Roman architect Vitruvius. In fact, the hall is entirely Roman in style.

The Lord Mayor lives and works in the unique historical setting of Mansion House, discharging their duties on behalf of the City and receiving major figures from business and government at home and overseas. Mansion House is the focus for many significant banquets and receptions, notably the Financial and Professional Services (formerly Bankers') Dinner at which the Chancellor of the Exchequer makes their annual Mansion House speech.

THE HEART OF THE CITY

This year's Lord Mayor's Dragon Awards have been organised by Heart of the City, of which the Rt Hon the Lord Mayor of the City of London is Co-President.

We're a charity funded by the City of London Corporation and City Bridge Trust, and we help small and medium businesses (SMEs) to support their people, places and planet through responsible business.

We do this through online workshops, mentoring and masterclasses that bring SMEs together to learn from experts in all areas of responsible business. We cover topics like employee wellbeing, supporting charities, getting to net zero and diversity, equity, and inclusion.

We help businesses put all this together into strategy that supports their business goals, and as you'll see tonight, lots of our SMEs go on to win awards for their responsible business efforts! We're proud to count lots of our members as Dragon Award winners.

One of the ways we reach SMEs is through the supply chain of some of the bigger businesses across London. These businesses have sponsored some of the SMEs in their supply chains to do our Foundations for Responsible Business programme or Climate for SMEs: 4 Steps to Action course, which has helped them with their responsible and sustainable goals.

The Lord Mayor's Appeal continues with its vision and ambition of creating, through our four strategic pillars, A Better City for All by supporting our partner charities and our thought leadership initiatives. Our work will benefit, City employees, residents and their family and friends, as well as those who live and work in our neighbouring communities with the one aim to create: A Better City for All – helping 1 million people thrive



Our partnership is enabling The Duke of Edinburgh's Award to extend its reach in London, supporting its ambition for a further 10,000 young people to have the chance to undertake and achieve an Award. This will give these young people the structured programmes of volunteering, physical and skills-based challenges to inspire, guide and support young people to succeed. They are focusing on growing provision in areas of deprivation, financing participations, expedition equipment and DofE leader training so that cost is not a barrier to taking part.



Low numeracy is holding 3.5 million Londoners back from fulfilling their potential, by increasing vulnerability to unemployment, debt, fraud and financial exclusion. Our partnership will fund a new initiative with National Numeracy – Every Londoner Counts – which will help improve employability and financial inclusion by supporting thousands of Londoners in greatest need to build confidence, skills and positive attitudes to basic numeracy through a network of 500 newlytrained Numeracy Champions. This work will help Londoners gain the crucial number skills they need to help them thrive.



Our partnership has enabled Place2Be to deliver a transformational mental health programme, active in 180 schools in London, equipping school leaders with the skills and knowledge to support their pupil's emotional and mental health. It is now also supporting Place2Think sessions giving staff a space to reflect with a Place2Be practitioner, focusing on the mental health needs of the whole school community.



Our partnership has supported OnSide to open three new state of the art Youth Zones in areas of high deprivation in London – Barking & Dagenham, Barnet and Croydon. Youth Zones are a game changer for young Londoners by offering them somewhere to go, something to do and someone to talk to through world class facilities and activities. They will help transform lives and communities tackling mental health, crime and employability prospects.



Our partnership has enabled Samaritans to develop and roll out to over 25,000 individuals in companies Wellbeing in the Workplace a revolutionary online programme for employees in London and beyond them. Funding has also supported the opening of the London City Hub, with listening volunteers focused solely on online chat. Introducing the online chat channel is an integral part of Samaritans plan to be around for future generations.
